Presidium's Motion to Amend IDSF Competition Rules

MOVED, that Rule 12 be amended as shown below with underlining and deletions:

Rule 12

Competition Dress

1. In all competitions granted under these **Rules**, For all IDSF granted competitions under RULE 5, competitors dress applies competitors shall dress or costume according to the **IDSF Dress Regulations**. These IDSF Dress Regulations are components of the IDSF competition , which form a part of these **Rules**. For greater certainty and without limiting the generality of this Rule, in For all age divisions the buttocks of the female partners must be covered at all the times as a minimum, during competition and "tangas" are not allowed may not be worn at any time. The chairman, or the IDSF Sports Director, has the right to disqualify any couple at the competition when either partner is not dressed or costumed according to this Rule, and in addition to its other powers under the **IDSF Statutes**. Furthermore the Presidium ~~is entitled to~~ is authorized to suspend ~~such couples~~ from competitions for a limited period of time any competitor who breaks this Rule.



2. In all IDSF Championships and Cups granted under these **Rules**, adjudicators serve as a team and shall dress or costume as follows:

(a) men: black or midnight-blue business suit, dress shirt, IDSF necktie, dress shoes; and

(b) women: black or midnight-blue business suit with either skirt or trousers, dress blouse, IDSF scarf, dress shoes.

Rule 12

Competition Dress

1. In all competitions granted under these **Rules**, competitors shall dress or costume according to the **IDSF Dress Regulations**, which form a part of these **Rules**. For greater certainty and without limiting the generality of this Rule, in all age divisions the buttocks of the female partners must be covered at all times during competition and “tangas” may not be worn at any time. The chairman, or the IDSF Sports Director, has the right to disqualify any couple at the competition when either partner is not dressed or costumed according to this Rule, and in addition to its other powers under the **IDSF Statutes** the Presidium is authorized to suspend from competitions for a limited period of time any competitor who breaks this Rule.

2. In all IDSF Championships, Cups and Grand Slams granted under these **Rules**, adjudicators serve as a team and shall dress or costume as follows:

(a) men: black or midnight-blue business suit, dress shirt, IDSF necktie, dress shoes; and



- (b) women: black or midnight-blue business suit with either skirt or trousers, dress blouse, IDSF scarf, dress shoes.

REASONS:

- 1. during several revisions Rule 12 has become somewhat disorganized. This amended version of Rule 12, set out in the new Rule 12(1), is better-organized and consequently easier to understand.**
- 2. to promote the policy that at all IDSF Championships and Cups, IDSF Adjudicators serve as a team and as representatives of IDSF.**
- 3. to promote the policy that we should direct attention to the athletes in the competition rather than the adjudicators.**
- 4. to correct some minor errors in English.**
